## INFORMATIONAL TEXT ON THE PROCESSING OF PERSONAL DATA

This privacy statement provides information about the processing and the protection of your personal data. On behalf of the Organizing Committee, Faculty of Law of the "Constitutional **Democracy and The Rule of Law: Mediterranean Perspectives**" international conference the Eastern Mediterranean University (hereafter 'the University' of "EMU") is committed to protect your personal data and to respect your privacy.

The University collects and further processes personal data pursuant to 89/2007 <u>Personal</u> <u>Data Protection Law</u>. We also protect your information by complying with General Data Protection Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) ("GDPR") principles in terms of EU requirements.

In accordance with the Law No. 89/2007 and the GDPR the University, as the controller of personal data, provides this information on how it processes personal data during the organization and hosting of the Conference.

#### 1) Who is the controller of your personal data?

The personal data controller is the University, with registered office at 99628, Famagusta, North Cyprus via Mersin 10 Turkey. Phone number of the University is +90 392 630 11 11. On behalf of EMU, as the processor Computer Center of the University is collection or administration of the University's web pages and The Center manages and processes public privacy, cookies, phishing information representing of the controller which is the EMU on behalf of the websites. Computer Center consists of employees of the University and it is a Center that operates under the University legal entity. ### 2) Has the controller appointed a data protection officer?

As a public authority, the controller is obliged under Article 10 of the Law No. 89/2007 and Article 37 (1)(a) of the GDPR to appoint a data protection officer ("Data Protection Officer") whose task is to ensure the protection of your personal data in cooperation with the controller. You can contact the Data Protection Officer of the University (<u>Assoc. Prof. Dr. Demet Çelik</u> <u>Ulusoy</u>) if you believe that the controller is processing your personal data in breach of the Law No. 89/2007 or GDPR and you can also exercise your rights under heading 8 of this data. The Data Protection Officer / Data Controller is an employee of the controller, the University who can be contacted as set out above.

## 3) Why does the controller process personal data?

The controller is always obliged to process personal data on the basis of at least one legal basis under Article 6 (1) and (2) of the Law No. 89/2007 and Article 6(1) of the GDPR. In the case of the organization and hosting of the Conference, your personal data is processed on the basis of Article 6(2) of the Law No. 89/2007 and Article 6(1) (b) GDPR. i.e. it is processing of personal data that is necessary for the performance of a written/unwritten contract. This contract is gratuitous and consists of an obligation on the part of the controller to provide the data subject with the Conference service.

### 4) To what amount is personal data processed?

Your personal data will be processed to the extent of identification data (name and surname) and contact data (e-mail). Registration for conference events will be limited to the purposes of performing the conference, such as reservations, transportation and providing services to you. It will only be used for conference and events within its scope and will only be shared with third parties for these purposes. Your data will not be used by us for commercial purposes in any way, but will be used for academic purposes and for the purposes of the conference.

#### 5) Does the controller transfer personal data to anyone else?

The controller will not pass on your personal data to any recipients of personal data. Your information is only shared with the organizing committee and its partners in order to conduct, plan, create and provide services to you in the conference and its scope. It is not shared or used for commercial purposes in any way.

## 6) Are personal data transferred to third countries2?

The controller does not transfer personal data to third countries.

### 7) How long will the controller process the personal data?

Your personal data will be processed for the period of the Conference. You may also be contacted after the Conference is over for reasons such as the delivery, sharing of Conference outputs. However, in these cases, your information is processed for conference purposes.

#### 8) What rights do I have with regard to the processing of my personal data?

As a data subject, you have the following rights:

**a. the right to withdraw your consent** - this right applies if you have given your consent to the processing of your personal data by registering for the Conference.

**b.** the right to request access to personal data - any data subject may request access to his or her personal data from the controller, within the scope and under the conditions set out in Article 14 of the Law No. 89/2007 and Article 15 of the GDPR.

**c. right to rectification** - every data subject has the right to request the controller to rectify his or her personal data on the basis of in Article 14 of the Law No. 89/2007 and Article 16 of the GDPR.

**d. right to restriction of processing** - each data subject has the right to apply to the controller and to request restriction of the processing of his or her personal data under the conditions set out in Article 15,16 of the Law No. 89/2007 and Article 18 of the GDPR.

**e. right to erasure** - the data subject has the right to request the controller to erase his or her personal data, under the conditions set out in Article 14 of the Law No. 89/2007 and Article 17 of the GDPR.

**f.** Portability of personal data - the data subject has the right to obtain from the controller the personal data concerning him or her where the processing is based on consent Article 5, 6 and 14 of the Law No. 89/2007 [Article 6(1)(a) GDPR] or on a contract [Article 6(1)(b) GDPR] and is carried out by automated means. The controller –the University must respond to these objections in writing within fifteen working days of submitting the request in the sense of the Article 15 (1) of the Law No. 89/2007.

**g. right to lodge a complaint** - every data subject has the right to lodge a complaint with a supervisory authority; the supervisory authority in the Turkish Republic of Northern Cyprus is the Office for Personal Data Protection, with its registered office at Bakanlıklar Yolu, Selçuklu Street, No. 3 Lefkoşa/TRNC via Mersin 10 Turkey, <u>TRNC Personal Data Protection Board</u>; the directorial authority is obliged to inform the complainant about the progress and outcome of the complaint Article 34 of the Law No. 89/2007. The Board is obliged to review the complaints and respond in writing to the relevant party within 30 days. (Article 77 GDPR) also the directorial authority is obliged to inform the complainant about the progress and outcome of the complaint every three months (Article 78(2) GDPR), otherwise the data subject has the right to effective judicial protection.

In order to obtain your data within the scope of the conference and provide you with the same scope of service, you must submit and consent from the registration and paper submission section in the official Conference Web site. Web: https://constitutionaldemocracy.emu.edu.tr/en
